1937 Shropshire Council Report

Cllr Martin Bennett read the Shropshire Council report provided by Cllr Joyce Barrow:

The river quality report and update will be going to my July scrutiny meeting, it's being delayed because the Environmental Agency and Natural Resources Wales launched a consultation a couple of weeks ago on the Severn Valley Water Management Scheme which Shropshire Council and Powys Council are also involved in so this would fit in well with the results from the consultation.

There is still time to apply for crowdfunding, Shropshire, a civic fundraising platform where community groups can get their projects funded by public and grant funding is currently open for applications until15th May. You can bid for up to £10,000 and up to £29,000 from the Green Space and Active Travel fund.

The Council's Trading Standards team have been out and about trying to prevent local retailers from selling vapes and other age restricted goods to young people under 18. Over the last year, the team undertook 59 purchases across the county, 17 for alcohol, 36 vapes and six knives.

The consultation is live on Waste and Recycling, I would urge everyone to take part. There is also a consultation launched to support the decision on future of the Schools Library Service

Cllr Martin Jones expressed concerns with application 24/00441/TPO and advised the Parish Council had objected to this application. He stated the house had been built in the wrong location, orientation, size, and access, and questioned how Shropshire Council planning had allowed this. He noted the hedgerow had been removed at the back of the site / property. Cllr Martin Bennett suggested noting the planning decisions in a) and communicate the Council's grave concerns over approval of this planning application despite the Council's views and no active enforcement.

Cllr Peter Oichardson provided a history of the site advising the Parish Council had objected strongly to the first application. Approval was granted for four plots all of which have not conformed to the original planning application. A re-application had to be submitted and retrospective approval granted. The second property referred to as the Embassy. This was not built to scale. There was a suggestion of engaging a Planning consultant to challenge the decision. Cllr Peter Richardson and Cllr Martin Jones both felt this would be a waste of money.

It was PROPOSED, SECONDED and AGREED to write to Shropshire Council raising concerns with approval of this application and to invite a planning officer to the next meeting to provide an explanation for the reasons in reaching this decision.

1947 Outcome of Casual Vacancy – Sychtyn Ward

Cllr Martin Bennett advised members the casual vacancy had been advertised following the resignation of Cllr Roger Jones. There has been no call for an election and the vacancy will be advertised through Co-option. Members **NOTED** this.

1948 Environmental Working Group

a)Water Pollution

Cllr Martin Jones advised members the plan had been to collect water samples with representatives of Montford Bridge and Up Sewage Creek in attendance. However, due to Cllr Iain Campbell's accident the deadlines were missed. There is no water testing this month. He proposed two additional tests will be performed at Rhydycroseau and by Morton Ley Farm at the bridge, unless Councillors have water courses with the Parish they wish to have assessed. Given its importance, water Testing will continue next year. Cllr Mike Weston offered to step in to cover during Cllr Iain Campbell's absence. Cllr Martin Jones advised he will speak with Kinnerley Parish Council, attend their next meeting, and provide an update. He also reported that a farmer from Montford Bridge had stopped growing potatoes due to the level of phosphates on the land having an adverse effect. Members **NOTED** the report on Water Pollution

b) Trefarclawdd Farm

No update

Cllr Mike Weston asked if a meeting had been agreed with Trefarclawdd farm . The Clerk confirmed a letter had been sent which the representative had acknowledged receipt of. The Clerk is waiting for details of proposed dates.

c) Vyrnwy Frankton Connection

Cllr Peter Richardson provided a detailed update to members on the Vyrnwy Frankton Connection meeting he attended at Pant which had been arranged by Helen Morgan MP. Around 180 people were in attendance. There was no representation from Green Gen / Bute Energy. The First presentation was given by a resident from Crickheath who will be severely affected if the project proceeds. Threatening letters have been issued regarding enforcement and access to land. It was noted, access to land cannot be gained without a Network Operations License. This has not yet been granted. Concerns were raised around expected disruption lasting 5 years, falls in house prices, no compensation, mobile / broadband connection issues, loss of visual amenity and costs for routing underground can be cheaper. The second presentation by Campaign for Rural Wales (CPRW) covered National Grids plans for five windfarms and plans by Green Gen to sell the license to other providers to build. This was followed by a questions and answers time from the audience. Helen Morgan MP summarised:

- To strategize and lobby the Minister responsible for making the decision
- Investigate Green Gen vs. Sven / National Grid
- To note the strength of feeling by local people

Cllr Martin Jones asked how the Independant Network Operation License was obtained, and Cllr Peter Richardson advised the company applied to Government . Helen Morgan MP has given her full support for this scheme to be underground.

It was PROPOSED, SECONDED and AGREED to write to Helen Morgan MP to advise the strength of public opinion and to invite the Minster responsible for the decision to visit the area. To arrange a venue to accommodate as many people as possible.

It was **NOTED** members supported the Protest Group.

1949 Cemetery

Cllr Martin Bennett advised members a request had been received from a resident to allow a wooden cross on a grave in Trefarclawdd Cemetery. Cllr Mike Weston asked if this had already been installed as he had seen a wooden cross lying on a grave in the newer part of the cemetery. He also wondered why given the concrete platform being in place for headstones. However, he expressed that permission should be granted. Members discussed this and there was a suggestion a wooden cross maybe due to financial constraints. Members felt a period of twelve months was appropriate

It was PROPOSED, SECONDED and AGREED for temporary permission to be granted for the installation of a wooden cross for an initial period of twelve months.

1950 Newsletter

a) Cllr Martin Bennett advised members of the suggestion as a Parish Council it produce a newsletter in September / October for all properties within the area. Alerting people that the Parish Council exists and draw attention to elections next year. Two newsletters have previously been produced for Morda & Sweeney Ward by Cllr Martin Bennett and Cllr Jaz Singh. A draft copy has been produced which should be published in the next few months. Cllr William Jones will provide an article on Water Pollution and Cllr Steve Watts an article on Road issues. Cllr Peter Richardson suggested the Council plan for it and felt some articles in the draft version were relevant across the Parish. Cllr Martin Bennett advised he had made enquires with The Royal Mail being able to deliver leaflets for

the Morda & Sweeny Ward for an estimated cost of £75 although his practice is to 'walk the ward' and deliver by hand as a way of meeting people and being made aware of emerging issues.

It was PROPOSED, SECONDED and AGREED to plan for a Parish Council newsletter.

1951 Shropshire Council Service Provision Cuts

a) Cllr Martin Bennett noted that since the agenda was prepared a number of additional consultations have been put in place . This includes the future of The Schools' Library Service and the Empty Homes Function. The Local Plan Inspector has asked for a consultation on the draft policy of Housing Provision for Older People. There is also the Additional Sustainability Appraisal of the draft Shropshire Local Plan, updated Housing & Employment Topic Paper and updated Green Belt Topic Paper. Cllr Martin Jones felt Shropshire Council were not taking responsibility for the mismanagement of the Council. He stated there was the plan for a loan of £28m for an unnecessary swimming pool. Members expressed it was difficult to assess all the consultations with so many being published at the same time. Members **NOTED** the consultations.

b) Cllr Matin Bennett advised members there had been a reasonable response from Parish Councils in the area to a meeting to discuss cuts in Service provision and impact on residents and local parishes. SALC issued a note earlier which Cllr Maritn Bennett read to members. This included details of a number of meetings with Town Council Clerks. Cllr Peter Richardson suggested as a priority the Parish Council contact Helen Morgan MP asking her to attend a meeting in September 2024 to discuss the service cuts and impact on the Parish Councils and Town Council in the local area and to note a positive response from local councils for this has been received. Also, to note the offer from Oswestry Town Council to host this proposed event.

It was PROPOSED, SECONDED and AGREED to write to Helen Morgan MP to ask her to attend a meeting with other local Parish Councils / Town Council to discuss the cuts in Service Provision and impact on Councils.

1952 Correspondence

a)Cllr Martin Bennett advised members of a resident's concerns / dissatisfaction regarding Shropshire Council's completed road works along Ball Lane, Maesbury. There was a brief discussion and Cllr Martin Jones advised members of his conversation with a Highways repairman conducting repairs on B4396.

It was PROPOSED, SECONDED and AGREED for the Chair to write to the resident regarding the works and to raise concerns with the responsible Authority Shropshire Council through Fix my Street.

1953 Consultations

a) Cllr Martin Bennett advised members of Shropshire Council consultation on the introduction of an annual charge for garden waste collection and the future operation of the council's five household recycling centres from 9 April to 20 May 2024.

It was PROPOSED, SECONDED and AGREED to write to Shropshire Council to raise concerns with the proposals on garden waste and recycling centres as part of the Public Consultation.

b)Members NOTED the Shrewsbury and Telford Hospital NHS Trust, Transformation Programme
