1.Apologies of absence

None

2.To Appoint Chair of Finance Committee

Members considered the appointment of a new Chair following the resignation of Cllr John Davies. It was PROPOSED, SECONED and AGRRED to appoint Cllr Martin Bennett as Chair of the Finance Committee.

3.Minutes of Meeting

The minutes of the Finance Committee meeting of the Parish Council held on 25 January 2024 were considered for approval.

It was PROPOSED, SECONDED and AGREED that the minutes of the meeting of 25 January 2024 be APROVED and ADOPTED as a true record.

4. Disclosure of Pecuniary of Interests, Bias, and Pre-determination

In accordance with Section 29 of the Localism Act 2011 Members are personally responsible for deciding whether or not they should disclose an interest at this meeting. Where a matter arises at a meeting which directly relates to a Member's Disclosable Pecuniary Interests they must disclose the interest, not participate in any discussion nor vote on the matter and must not remain in the room unless they have been granted a dispensation. If it is a 'sensitive interest,' Members do not have to disclose the nature of the interest, just that they have an interest. (Please refer to Appendix B in the Council's Code of Conduct). Members are also reminded they should not make decisions with a closed mind and must declare a bias and not vote on matters where their decision could be considered to be pre-determined.

5. Internal Audit 2023/24

The Clerk advised the audit for 2023/24 had not been concluded by the internal auditor. The AGAR 2023/24 and the internal audit report should be finalised before Full Council meeting and the outcome will be shared with members then.

6. Annual Governance and Accounting Return 2023/24

i. Members reviewed the Annual Governance and Accounting Return 2023/24, subject to any internal audit findings.

It was PROPOSED, SECONDED and AGREED to recommend the approval of the Annual Governance and Accounting Return 2023/24 subject to the findings of the internal audit.

The Clerk advised there were no changes to the other TOR.
