In terms of restoration it's activities have focused on the Montgomery Canal.	The grant applied aims to : Extend the improved towpath towards Schoolhouse Bridge for would fund materials and plant hire for construction of a surfaced towpath, continuing on from where the restored towpath currently terminates to a point where it is anticipated a Natural England licence will be required before further progress can be made. This is a distance of 90 metres. A CRT standard specification will be used. This comprises a compacted aggregate sub-base over a woven geotextile sheet material and between tanalised boards to form a level, self-draining surface 1.2m in width. All volunteer welfare costs, sundries and project overheads will be borne by the Society.	All members of the general public. Access to the towpath is free at the point of use and totally unrestricted in terms of qualification e.g. membership or residency. There is particular emphasis on providing restricted mobility access as the towpath itself is a stable, level, safe means of enjoying both natural and heritage environments. The canal towpath passes through the Oswestry Rural Parish Council area for some 8,600m. SUCS has to date restored 1500m of this length making it ideal for recreation in the form of walking, cycling and running, and as a safe active travel route.	1,500.00

We are lucky at Hope House to have a large and beautiful outdoor space, but unfortunately at present it lacks proper access and cohesion so that we are not able to give all the children and young people we care for an equal opportunity to enjoy experiences outdoors. Many of our children have physical disabilities, often in combination with severe and profound learning disabilities, sensory needs and autistic tendencies.	It is often said that you don't know a hospice is there until you need it. We are currently supporting 165 children and their families who directly access support from the hospice itself. This includes 7 families in Oswestry. As well as that, 211 bereaved families also access connect with us at the hospice with 23 of those families being from an Oswestry postcode. This may be through respite care, end of life, counselling or sibling support. All of these families are connected inextricably with the hospice and find solace and comfort in the warm, friendly environment we have created. A real home from home. These families.... your families and their children are able to access equipment that really helps them to be stimulated when often they struggle with communicating. This type of equipment, to be used in a medical environment, is often expensive due to its composition and inaccessible for a domestic environment. We feel that our families and their children should have access to the best equipment available to provide that stimulation and engagement in order to make long lasting memories. Now the field is used continually the maintenance Costs are obviously higher and the Committee would appreciate a grant to support their efforts in keeping the field in good condition. We will need to have enough money to take care of the pitch after the winter's football games. Also, we wish to plant a couple of replacement trees that were damaged in storms.	The Field is the venue for football practice and matches of the Llanymynech Junior Football Teams , TNS ladies and girls' team and Morton Ladies Rounders Team. The young people of Maesbury, Morton and Crickheath use the field for recreations as no such space or play facilities exist in those areas, also they can walk safely along the Montgomery Canal towpath to access the field . The general community use the field too for exercise and a seat was installed so that people could benefit from the lovely views in a peaceful spot enjoying bird song. The space between the entrance and the pitch sometime use for park when funerals are held in the church which keeps the lane and junction free from vehicles. The Committee use the field for occasional fund raising activities. Finally the Committee raised £4,000 to install a defibrillator on the verge outside the field which can be used by community in an emergency as well as participants in sports on the field. The cost was higher than normal as there was no power supply available and the installing was innovative by being mounted on a post with an underground connection. Oswestry Rural Parish Council contributed £595 to that project in 2021.	450.00
